The purpose of this Notice dated 5 March 2019 is to inform any holder of Notes that the Issuer has modified the terms and conditions of the Notes by amending and restating the final terms of each

of the Notes in connection with incorporating the Issuer's interim report for the fourth quarter 2018 to the Guaranteed Euro Medium Term Note Programme.

The definition of "Change of Control" in Condition 6 (f) (i) of the Notes have been amended so that a Change of Control shall mean:

"any person or group of persons acting in concert (as defined below), in each case either directly or indirectly, shall acquire ownership of, or otherwise control, one or more classes of the shares in the capital of the Issuer carrying in aggregate more than 50 per cent. of the voting rights normally exercisable at a general meeting of the Issuer (the "**Change of Control**");"
