Translation of Minutes of the Annual General Meeting of shareholders of Tele2 AB (publ), Reg. No. 556410-8917, 15 May 2024 in Stockholm.

§ 1

Opening of the Annual General Meeting (agenda item 1)

The General Meeting was declared opened by the Chairman of the Board Andrew Barron.

It was noted that the General Meeting was held with physical presence of shareholders and with the option for shareholders to exercise their voting rights by advance voting (postal voting) pursuant to the articles of association.

§ 2

Election of Chairman of the Annual General Meeting (agenda item 2)

The General Meeting elected the lawyer David Andersson, member of the Swedish Bar Association, from the law firm Vinge as Chairman of the General Meeting.

It was noted that Helena Wanhainen, Head of Legal of Tele2, had been appointed to keep the minutes.

The General Meeting resolved that certain persons who were not shareholders were entitled to attend the General Meeting, but without the rights to address the General Meeting or to participate in the General Meeting's resolution.

§ 3

Preparation and approval of the voting list (agenda item 3)

The General Meeting approved the enclosed list, <u>Appendix 1</u>, as voting list for the Annual General Meeting.

§ 4

Approval of the agenda (agenda item 4)

The General Meeting approved the agenda proposed in the notice, <u>Appendix 2</u>, as agenda for the Annual General Meeting.

§ 5

Election of one or two persons to check and verify the minutes (agenda item 5)

The General Meeting appointed Alexandra Bartholdsson Frenander, representing Folksam and KPA Pension, to approve the minutes together with the Chairman.

§ 6

Determination of whether the Annual General Meeting has been duly convened (agenda item 6) The General Meeting resolved to declare the Annual General Meeting duly convened.

Remarks by the Chairman of the Board (agenda item 7)

The Chairman of the Board Andrew Barron gave his remarks on the work of the Board during 2023.

§ 8

Presentation by the Chief Executive Officer and other presentations, including climate transition plan (agenda item 8)

The CEO Kjell Johnsen held a presentation regarding Tele2's business and development as well as Tele2's future priorities. Furthermore, Erik Wottrich, Head of Sustainability, held a presentation on Tele2's climate transition plan and Elin Ovéus, Head of Networks, held a presentation on the company's roll-out of the 5G network and the decommissioning of the 2G and 3G networks.

§ 9

<u>Presentation of the annual report and the auditor's report and the consolidated financial</u> <u>statements and the auditor's report on the consolidated financial statements (agenda item 9)</u>

It was established that the annual report, the auditor's report, consolidated accounts and the auditor's report on the consolidated accounts for the 2023 financial year had been presented on 2 April 2024 and that the auditor's report pursuant to Chapter 8, Section 54 of the Swedish Companies Act had been presented on 8 April 2024. It was noted that the documentation had been presented by being made available on the company's website and at the company's headquarters.

Auditor-in-charge, Didrik Roos, Deloitte, reported on the audit work and commented on the Auditor's report and the guidelines for remuneration to senior executives in respect of the parent company and the Group for 2023.

§ 10

Resolution on the adoption of the income statement and the balance sheet and of the consolidated income statement and the consolidated balance sheet (agenda item 10)

The General Meeting resolved to adopt the income statements for 2023 and balance sheets as of 31 December 2023 for the parent company and the Group.

§ 11

<u>Resolution on the proposed treatment of the company's earnings as stated in the adopted balance</u> <u>sheet (agenda item 11)</u>

The General Meeting resolved, in accordance with the Board's proposal, that an ordinary dividend of SEK 6.90 per share shall be paid.

The General Meeting further resolved, in accordance with the Board's proposal, that the dividend shall be paid out in two separate payments, each of SEK 3.45 per share and that the record date shall be 17 May 2024 for the first payment and 15 October 2024 for the second payment. The General Meeting resolved to dismiss the shareholder Sune Gunnarsson's proposal that the dividend be paid on one occasion with the record date of 17 May.

It was noted that the first payment of the dividend is estimated to be paid to the shareholders on 22 May 2024 and that the second payment of the dividend is estimated to be paid to the shareholders on 18 October 2024.

§ 12

Resolution on the discharge of liability for the members of the Board and the Chief Executive Officer (agenda item 12)

The General Meeting discharged the Board members and the CEO from liability for the administration of the company during 2023.

It was noted that none of the individuals who had served as Board member or CEO participated in this resolution regarding the individual concerned.

§ 13

Determination of the number of members of the Board (agenda item 13)

The General Meeting resolved, in accordance with the Nomination Committee's proposal, that the Board shall consist of eight members for the period until the end of the next Annual General Meeting.

§ 14

Determination of the remuneration to the members of the Board and the auditor (agenda item 14)

The General Meeting resolved, in accordance with the Nomination Committee's proposal, that remuneration for ordinary Board and committee work for the period until the end of the next Annual General Meeting shall be distributed in accordance with the following:

- SEK 1,854,000 (SEK 1,800,000) to the Chairman of the Board,
- SEK 680,000 (SEK 660,000) to each other member of the Board,
- SEK 259,000 (SEK 251,000) to the Chairman of the Audit Committee and SEK 130,000 (SEK 126,000) to each other member, and
- SEK 108,000 (SEK 105,000) to the Chairman of the Remuneration Committee and SEK 55,000 (SEK 53,000) to each other member.

The General Meeting resolved, in accordance with the Nomination Committee's proposal, that remuneration to the auditor shall be paid in accordance with approved invoices.

§ 15

Election of Board members (agenda items 15)

The General Meeting resolved, in accordance with the Nomination Committee's proposal, on re-election of the Board members Stina Bergfors, Sam Kini, Eva Lindqvist and Lars-Åke Norling and new election of Nicholas Högberg, Thomas Reynaud, Aude Durand and Jean-Marc Harion.

It was noted that information regarding the proposed Board members' assignments in other companies had been available on the company's website since 8 April 2024.

§ 16

Election of the Chairman of the Board (agenda item 16)

The General Meeting resolved, in accordance with the Nomination Committee's proposal, to elect Thomas Reynaud as new Chairman of the Board.

§ 17

Determination of the number of Auditors and election of Auditor (agenda item 17)

The General Meeting resolved, in accordance with the Nomination Committee's proposal, that the company shall have one registered audit firm as auditor and to re-elect the registered audit firm KPMG AB as auditor for the period until the end of the 2025 Annual General Meeting.

It was noted that KPMG AB has informed that the authorized auditor Tomas Gerhardsson will be appointed as auditor-in-charge.

§ 18

Presentation of the Board's remuneration report for approval (agenda item 18)

The General Meeting resolved to approve the Board's remuneration report.

§ 19

Resolutions regarding an incentive programme (agenda items 19(a)-(f))

The General Meeting resolved, in accordance with the Board's proposal included in the notice convening the General Meeting, items 19(a)-(c) and (e) on the agenda, on adoption of an incentive programme (item 19(a)), authorisation to resolve to issue Class C shares (item 19(b)), authorisation to resolve to repurchase own Class C shares (item 19(c)) and on authorisation to resolve to sell own Class B shares (item 19(e)). It was noted that the resolutions pursuant to items 19(b), 19(c) and 19(e) were supported by shareholders representing at least two thirds of the votes cast and the shares represented at the Annual General Meeting.

The General Meeting further resolved, in accordance with the Board's proposal included in the notice convening the General Meeting, on the transfer of own Class B shares pursuant to item 19(d). It was noted that the resolution pursuant to item 19(d) was supported by shareholders representing at least nine tenths of the votes cast and the shares represented at the Annual General Meeting.

It was further noted that the Annual General Meeting did not consider the proposal pursuant to item 19(f), since the proposal pursuant to item 19(d) had been approved.

§ 20

Resolution to authorise the Board to resolve on repurchase of own shares (agenda item 20)

The General Meeting resolved, in accordance with the Board's proposal, to authorise the Board to resolve to repurchase own shares.

It was noted that the resolution pursuant to item 20 was supported by shareholders representing at least two thirds of the votes cast and the shares represented at the Annual General Meeting.

§ 21

Resolutions regarding shareholder Martin Green's proposals (agenda items 21(a)-(c))

The General Meeting resolved to dismiss shareholder Martin Green's proposal pursuant to items 21(a)-(c).

§ 22

Closing of the Annual General Meeting (agenda item 22)

The Chairman declared the Annual General Meeting closed.

Election of Chairman of the Annual General Meeting (item 2)

The Nomination Committee proposes that David Andersson, member of the Swedish Bar Association, from the law firm Vinge is elected to be the Chairman of the Annual General Meeting.

Determination of the number of members of the Board and election of Board members (items 13 and 15)

On 26 February 2024 it was announced that Freya Investissement ("**Freya**"), an investment vehicle jointly controlled by the European telecommunications group iliad and its Chairman and founder Xavier Niel through NJJ Holding, has entered into an agreement to acquire Kinnevik's shareholding in Tele2. The transaction is completed in three steps of which the first has been completed, resulting in

Freya holding 3.49 percent of the votes in Tele2. The second step will be completed following foreign direct investment clearances expected to be received during the second quarter of 2024. Upon completion of this second step, Freya will hold 28.82 percent of the votes in Tele2, and become its largest shareholder. In light of the transaction, the Nomination Committee proposes the following composition of the Board to the Annual General Meeting 2024, amending the proposal announced on 31 January 2024.

The Nomination Committee proposes that the Board shall consist of:

- if applicable, seven members during the period from the Annual General Meeting up until the date on which Freya and Kinnevik have completed the second step of the transaction, and
- eight members effective as from the date on which Freya and Kinnevik have completed the second step of the transaction and until the end of the next Annual General Meeting.

The Nomination Committee further proposes that:

- Stina Bergfors, Georgi Ganev, Sam Kini, Eva Lindqvist and Lars-Åke Norling shall be re-elected as members of the Board, and that Nicholas Högberg and Thomas Reynaud shall be elected as new members of the Board effective as from the Annual General Meeting, and
- Aude Durand and Jean-Marc Harion shall be elected as new members of the Board effective as from the date on which Freya and Kinnevik have completed the second step of the transaction. Georgi Ganev has declared that he, at the same time, will resign as member of the Board.

The Nomination Committee's proposals entail that if:

- Freya and Kinnevik have completed the second step of the transaction before or at the time of the Annual General Meeting, the Board will consist of eight members, being Stina Bergfors, Aude Durand, Jean-Marc Harion, Nicholas Högberg, Sam Kini, Eva Lindqvist, Lars-Åke Norling and Thomas Reynaud, and
- Freya and Kinnevik have not completed the second step of the transaction at the time of the Annual General Meeting, the Board will for the period between the Annual General Meeting and the date on which Freya and Kinnevik completes the second step of the transaction, consist of seven members, being Stina Bergfors, Georgi Ganev, Nicholas Högberg, Sam Kini, Eva Lindqvist, Lars-Åke Norling and Thomas Reynaud. When Freya and Kinnevik have completed the second step of the transaction, Aude Durand and Jean-Marc Harion will join the Board as new members and Georgi Ganev will, at the same time, leave the Board.

The term-of-office for all Board members is until the end of the next Annual General Meeting.

Determination of the remuneration to the members of the Board and the auditor (item 14)

The Nomination Committee proposes that remuneration for ordinary Board and committee work for the period until the end of the next Annual General Meeting is to be increased with approximately 3 percent per member level and will be allocated in accordance with the following:

- SEK 1,854,000 (compared to SEK 1,800,000 last year) to the Chairman of the Board,
- SEK 680,000 (compared to SEK 660,000 last year) to each other member of the Board,
- SEK 259,000 (compared to SEK 251,000 last year) to the Chairman of the Audit Committee and SEK 130,000 (compared to SEK 126,000 last year) each other member, and
- SEK 108,000 (compared to SEK 105,000 last year) to the Chairman of the Remuneration Committee and SEK 55,000 (compared to SEK 53,000 last year) to each other member.

The remuneration shall be paid in proportion to the length of each Board member's term-of-office.

The Nomination Committee proposes that remuneration to the auditor shall be paid in accordance with approved invoices.

Election of Chairman of the Board (item 16)

The Nomination Committee proposes that Thomas Reynaud shall be elected as the new Chairman of the Board.

Determination of the number of Auditors and election of Auditor (item 17)

In accordance with the Audit Committee's recommendation, the Nomination Committee proposes that Tele2 shall have one registered accounting firm as Auditor, and that the registered accounting firm KPMG AB shall be elected as new Auditor until the end of the 2025 Annual General Meeting. KPMG AB has informed Tele2 that the authorised public accountant Tomas Gerhardsson will be appointed Auditor-in-charge if KPMG AB is elected as new Auditor.

Resolutions proposed by the Board

Resolution on the proposed treatment of the company's earnings as stated in the adopted balance sheet (item 11)

The Board proposes an ordinary dividend of SEK 6.90 per share. The dividend is proposed to be paid in two separate payments of SEK 3.45 per share each. The record date shall be 17 May 2024 for the first payment and 15 October 2024 for the second payment.

If the Annual General Meeting resolves in accordance with the proposal, the first tranche of the dividend payment will be paid to the shareholders on 22 May 2024 and the second tranche of the dividend payment will be paid out to the shareholders on 18 October 2024.

Incentive programme (items 19 (a)-(f))

The Board proposes that the Annual General Meeting resolves to adopt a performance-based incentive programme in accordance with items 19(a)-(f) below.

Tele2's Remuneration Committee has prepared the incentive programme in consultation with external advisors and major shareholders. The incentive programme has been reviewed by the Board at Board meetings during the end of 2023 and the first months of 2024.

Adoption of an incentive programme (item 19(a))

Summary of the programme

The Board proposes that the Annual General Meeting resolves to adopt a performance-based incentive programme ("**LTI 2024**") based on the corresponding structure as last year, but with removal of the performance parameter Absolute TSR and with addition of an ESG performance measurement – which is proposed to be a CDP score. The metrics and conditions are further described in this proposal.

LTI 2024 is proposed to include approximately 200 senior executives and other key employees within the Tele2 Group. The participants in LTI 2024 are required to hold Tele2 shares. These shares can either be shares already held or shares purchased on the market in connection with the notification to participate in LTI 2024. The personal investment will thereafter be matched by the company through free-of-charge granting of performance rights on the terms stipulated below.

In the event delivery of shares under LTI 2024 cannot be achieved at reasonable costs, with reasonable administrative efforts or due to market conditions, participants may instead be offered a cash-based settlement.

The rationale for the proposal

The purpose of LTI 2024 is to create conditions for retaining competent employees in the Tele2 Group. LTI 2024 has been designed based on the view that it is desirable that senior executives and other key employees within the group are shareholders in the company. Participation in LTI 2024 requires a

personal investment in Tele2 shares, be it shares already held or shares purchased on the market in connection with the notification to participate in LTI 2024. Further LTI 2024 requires, with certain exceptions, the employee to remain employed until the day after the release of the interim report for January – March 2027.

By offering an allotment of performance rights which are based on the fulfilment of defined profits and activity-based conditions, the participants are rewarded for increased shareholder value. Further, LTI 2024 rewards employees' loyalty and long-term value growth in the company. Against this background, the Board believes the adoption of LTI 2024 will have a positive effect on the Tele2 Group's future development and thus be beneficial for both the company and its shareholders.

Personal investment

Employees must own Tele2 shares in order to participate in LTI 2024. These shares can either be shares already held, provided that the shares are not used as investment shares under the sharebased incentive programmes for the years 2022 or 2023, or shares purchased on the market in connection with notification to participate in LTI 2024. The maximum number of shares that the employee can hold under LTI 2024 will correspond to approximately 9 - 18 percent of the employee's annual base salary as further described below. For each Tele2 share held under LTI 2024, the participants will be granted performance rights by the company.

General terms and conditions

Subject to fulfilment of certain performance-based conditions during the periods 1 January 2024 – 31 December 2026 (the "**Cash flow and CDP score Measurement Period**") and 1 April 2024 – 31 March 2027 (the "**TSR Measurement Period**") and the participant maintaining the invested shares at the release of the interim report for January – March 2027 and, with certain exceptions, maintaining the employment within the Tele2 Group, each right entitles the participant to receive one Tele2 share free-of-charge. The performance rights do not entitle the holder to receive dividends, but in order to align the participants' and the shareholders' interests, the company will compensate the participants for any dividends paid on the underlying shares during the vesting period, by increasing the number of shares that each performance right entitles to at the end of the vesting period. It should be noted that the participants in LTI 2024 will not be compensated for dividend proposed at the Annual General Meeting 2024 if the dividend is executed prior to grant of rights of the LTI 2024 programme.

Performance conditions

The rights are divided into Series A, Series B and Series C (performance rights). The number of Class B shares the respective participant will receive after vesting depends on which category the participant belongs to and on the fulfilment of the following defined performance-based conditions for each respective Series rights:

Series A: The total shareholder return on the Tele2 shares (TSR) during the TSR Measurement Period being equal to the median TSR for a peer group comprising BT Group, Deutsche Telekom, Elisa, Freenet (Xet), Koninklijke KPN, NOS SGPS, Orange, Proximus, Swisscom, Telecom Italia, Telefonica, Telekom Austria, Telenor, Telia Company and Vodafone as entry level, and exceeding the median TSR for the peer group with 10 percentage points as the stretch level.

Series B: Cash flow¹ shall be measured on cumulative basis for the consolidated Tele2 Group during the Cash flow and CDP Measurement Period for LTI 2024. The Board shall establish appropriate target levels according with the external financial guidance by Tele2. As an entry level for allotment of the Cash flow target, 90 percent of the target level has to be reached and in order to reach stretch level, 110 percent of the target level has to be reached. The performance-based condition for rights of Series B are measured on a cumulative basis during the Cash Flow and CDP score Measurement Period and appropriate target levels will be established by the Board in accordance with the financial guidance by Tele2. As the financial guidance is established annually it is not possible to set a final three-year target for the performance condition beforehand. However, to enable shareholders and other stakeholders to keep updated on how this performance-based condition is developing, the Board

intends to on an annual basis in Tele2's Annual and Sustainability report disclose if, and to what extent, the target level for cash flow - as established by the Board for the reported year based on financial guidance for that year - has been reached.

Series C: Tele2 is measured on cumulative basis for the consolidated Tele2 Group during the Cash flow and CDP Measurement Period. The CDP score is meausured by external vendor on annual basis, with a CDP score for 2024, 2025 and 2026. The score delivered by CDP will give a performance achievement in percent, where score "A" gives a performance achievement of 100 percent, score "-A" gives 75 percent performance achievement and score "B" 50 percent performance achievement, each year. Below the score "B", will give 0 percent performance achievement. A weighted average score for all three years will give the outcome of performance shares to vest. If the minimum level for Series C is reached for one single year (B) and below B for the other two years 16,67 percent of the number of rights vest. If "A" is reached all three years 100 percent of the performance rights vest.

The determined levels of the conditions include an "entry" and a "stretch" with a linear interpolation applied between these levels as for Series A and B as regards the number of rights that vest. The entry level constitutes the minimum level which must be reached in order to enable vesting of the rights in the relevant series. If the entry level is reached, the number of rights that vests and give right to Class B shares is proposed to be, 50 percent for Series A and 30 percent for Series B. If the entry level is not reached for a certain series, all performance rights (as applicable) in that series lapse. If the stretch level for Series A and Series B are met, all performance outcome of the three year measurements for CDP. The Board intends to disclose the outcome of the performance-based conditions in the annual report for the financial year 2027.

Retention based conditions and performance rights

The retention based conditons and performance rights shall be governed by the following terms and conditions:

- They are granted free-of-charge after the Annual General Meeting 2024.
- They vest three years after grant (vesting period).
- Each right entitles the participant to receive one Tele2 share after the three-year vesting period, if the participant, with certain exceptions, maintains the employment within the Tele2 Group and the invested shares at the release of the interim report for the period January March 2027.
- In order to align the participants' and the shareholders' interests, the company will compensate the participants for any dividends paid by increasing the number of shares that each performance right entitles to at the end of the vesting period. It can be noted that the participants in LTI 2024 will not be compensated for the dividend proposed at the Annual General Meeting 2024, if the dividend is executed prior to grant of rights of the LTI 2024 programme.
- They may not be transferred or pledged.

Preparation and administration

The Board, or a committee established by the Board for these purposes, shall be responsible for preparing the detailed terms and conditions of LTI 2024, in accordance with the mentioned terms and guidelines. To this end, the Board shall be entitled to make adjustments to meet foreign regulations or market conditions. The Board may also make other adjustments if significant changes in the Tele2 Group or its operating environment would result in a situation where the decided terms and conditions of LTI 2024 no longer serve their purpose. The Board is proposed to have the right to adjust for items affecting the original target setting, i.e. items that are deemed not be related to ordinary course of business and similar items at time of the original target setting. The Board's possibility to make such adjustments does not include the grant of continued participation for senior executives in the company's long-term incentive programmes after the termination of their respective employments.

Allocation

LTI 2024 is estimated to comprise up to 363,000 shares held by the participants entitling to allotment of up to 1,725,000 performance rights. The participants are divided into different categories and in accordance with the above, LTI 2024 will comprise the following number of shares and maximum number of rights for the different categories:

- the CEO: may acquire up to 20,000 shares within LTI 2024, entitling to an allotment of 3.5 Series A rights, 4.5 Series B rights and 2 Series C rights per invested share, with the possibility to receive a maximum of 200,000 Tele2 shares at vesting;
- senior executives and certain key employees (approximately 10 individuals) are divided into two subcategories where category (1) (approximately 3 individuals) may acquire up to 7,500 shares each within LTI 2024, entitling the holder to allotment of 2.5 Series A rights, 4 Series B rights and 1.5 Series C rights per invested share, with the possibility to receive a maximum of 60,000 Tele2 shares at vesting. Category (2) (approximately 7 individuals) may acquire up to 4,500 shares each within LTI 2024, entitling the holder to allotment of 1.75 Series A rights, 3 Series B rights and 1.25 Series C rights per invested share, with the possibility to receive a maximum of 27,000 Tele2 shares at vesting;
- category 3 (approximately 25 individuals in total): may acquire up to 3,000 shares each within LTI 2024, entitling the holder to allotment of 1 Series A right, 2 Series B rights and 1 Series C right per invested share, with the possibility to receive a maximum of 12,000 Tele2 shares at vesting;
- category 4 (approximately 50 individuals in total): may acquire up to 2,000 shares each within LTI 2024, entitling the holder to allotment of 1 Series A right, 2 Series B rights and 1 Series C right per invested share, with the possibility to receive a maximum of 8,000 Tele2 shares at vesting; and
- category 5 (approximately 114 individuals in total): may acquire up to 1,000 shares each within LTI 2024, entitling the holder to allotment of 1 Series A right, 2 Series B rights and 1 Series C right per invested share, with the possibility to receive a maximum of 4,000 Tele2 shares at vesting.

Scope and costs

LTI 2024 will be accounted for in accordance with IFRS 2 which stipulates that the rights should be recorded as a personnel expense in the income statement during the vesting period. Based on the assumptions of a share price of SEK 83.47 (closing share price of the Tele2 Class B share on 29 February 2024 of SEK 86.92 reduced by the first tranche of the proposed dividend, amounting to SEK 3.45 per share, which is distributed from underlying share before the launch of LTI 2024), a maximum participation, an annual employee turnover of 10 percent among the participants, a fulfilment of performance conditions of 50 percent, the cost for LTI 2024, including financing costs, but excluding social security costs, is estimated to approximately SEK 55 million. The cost will be allocated over the years 2024 – 2027. At a 100 percent fulfilment of the performance conditions, the total cost is estimated to approximately SEK 94 million, according to IFRS 2.

The calculated social security cost will be recorded as a personnel expense in the income statement by current reservations. The social security cost is estimated to approximately SEK 26 million with the assumptions above (approximately SEK 51 million at a 100 percent fulfilment of the performance conditions), an average social security charge rate of 30 percent and an annual share price increase for Tele2's Class B shares of 10 percent during the vesting period.

The participant's maximum profit per right in LTI 2024 is limited to SEK 324.33, which equals to four times the average closing share price of the Tele2 Class B share during February 2024 with deduction for the proposed dividend, which is distributed from underlying share before the launch of LTI 2024. If the value of the Tele2 B-share exceeds SEK 324.33 at vesting, the number of Class B shares that each right entitles the participant to receive at vesting will be reduced correspondingly.

The maximum dilution is up to 0.25 percent of outstanding shares, 0.19 percent of votes and 0.22 percent in terms of costs for LTI 2024. The maximum dilution in terms of outstanding shares and votes has been calculated before any recalculation for dividends paid on the underlying shares during the

vesting period. The dilution in terms of costs has been calculated in accordance with IFRS 2, divided by Tele2's market capitalisation, excluding the dividend proposed to the Annual General Meeting 2024. Together with rights granted under the incentive programmes for the years 2021, 2022 and 2023, the maximum dilution is up to 0.89 percent of outstanding shares and 0.69 percent of votes.

If the maximum profit of SEK 324.33 per right is reached, all invested shares are retained under LTI 2024 and a fulfilment of the performance conditions of 100 percent, the maximum cost, as defined in IFRS 2, is estimated to SEK 128 million and the maximum social security cost is estimated to SEK 168 million.

For information on Tele2's other equity-related incentive programmes, reference is made to the Annual & Sustainability report for 2023, note 31.

Effect on key ratios

If LTI 2024 had been introduced in 2023 with the assumptions stated above, including a fulfilment of performance conditions resulting in 50 percent vesting of performance rights, the diluted earnings per share would have decreased by 0.6 percent, from SEK 5.37 to SEK 5.34 on a pro forma basis.

The annual cost of LTI 2024, including financing costs and social security costs, is estimated to approximately SEK 28 million given the above assumptions. This cost can be related to the company's total personnel costs, including social security costs, of SEK 3,620 million in 2023.

Delivery of Class B shares

To ensure the delivery of shares under LTI 2024, as well as other outstanding equity-related incentive programmes, the Board proposes that the Annual General Meeting resolves to authorise the Board to resolve on a directed issue of Class C shares to Nordea Bank in accordance with item 19(b), and further to authorise the Board to subsequently resolve to repurchase the Class C shares from Nordea Bank in accordance with item 19(c). The Class C shares will then be held by the company, whereafter the appropriate number of Class C shares will be reclassified into Class B shares and subsequently be delivered to the participants under LTI 2024 as well as other outstanding equity-related incentive programmes.

The Board further proposes that the Annual General Meeting resolves that a maximum of 2,070,000 Class B shares may be transferred to the participants in accordance with the terms of LTI 2024. These shares can either be Class B treasury shares held by the company or Class B shares held by the company after reclassification from Class C shares.

In the event delivery of shares under LTI 2024 cannot be achieved as a result of the majority requirement for item 19(d) not being met, participants may instead acquire Class B shares from a third party who has entered into an equity swap agreement with Tele2, provided that the Annual General Meeting resolves in accordance with the proposal in item 19(f) below.

Authorisation to issue Class C shares (item 19(b))

The Board proposes that the Annual General Meeting resolves to authorise the Board, during the period until the Annual General Meeting 2025, to increase the company's share capital by not more than SEK 2,450,000 by the issue of not more than 1,960,000 Class C shares, each with a ratio value of SEK 1.25. With disapplication of the shareholders' preferential rights, Nordea Bank shall be entitled to subscribe for the new Class C shares at a subscription price corresponding to the ratio value of the shares. The purpose of the authorisation and the reason for the disapplication of the shareholders' preferential rights in connection with the issue of shares is to ensure delivery of Class B shares to participants under LTI 2024 as well as in accordance with LTI 2021 – LTI 2023.

Authorisation to resolve to repurchase own Class C shares (item 19(c))

The Board proposes that the Annual General Meeting resolves to authorise the Board, during the period until the Annual General Meeting 2025, to repurchase its own Class C shares. The repurchase may only be effected through a public offer directed to all holders of Class C shares and shall

comprise all outstanding Class C shares. The purchase may be effected at a purchase price corresponding to not less than SEK 1.25 and not more than SEK 1.35 per share. Payment for the Class C shares shall be made in cash. The purpose of the repurchase is to ensure the delivery of Class B shares under LTI 2024 as well as in accordance with LTI 2021 – LTI 2023.

Resolution on the transfer of own Class B shares (item 19(d))

The Board proposes that the Annual General Meeting resolves that Class C shares that the company purchases by virtue of the authorisation to repurchase its own Class C shares in accordance with item 19(c) above, following reclassification into Class B shares, may be transferred to participants in LTI 2024, to participants in other outstanding equity-related incentive programmes in accordance with the approved terms, or sold on Nasdaq Stockholm as set out in accordance with item 19(e) below.

The Board proposes that the Annual General Meeting resolves that a maximum of 2,070,000 Class B shares may be transferred to participants in accordance with the terms of LTI 2024. These shares can either be Class B treasury shares held by the company or Class B shares held by the company after reclassification from Class C shares.

Resolution on the sale of own Class B shares (item 19(e))

The Board proposes that the Annual General Meeting authorises the Board to resolve, on one or more occasions, for the period up until the Annual General Meeting 2025, to sell Class B shares on Nasdaq Stockholm. The number of Class B shares to be sold may not exceed the number of Class B shares that the company holds at the point in time of the Board's resolution. Sale of Class B shares may only be in consideration of cash payment at a price within the share price interval registered at that time, meaning the interval between the highest purchase price and the lowest selling price.

The purpose of the authorisation is to ensure the company's undertakings, including social security costs and payment of preliminary salary tax, in connection with delivery of shares to the participants in Tele2's long-term incentive programme LTI 2022 – LTI 2024.

Resolution on equity swap agreement with a third party (item 19(f))

Should the majority requirement for item 19(d) above not be met, the Board proposes that the Annual General Meeting resolves that Tele2 can enter into an equity swap agreement with a third party on terms in accordance with market practice, whereby the third party in its own name shall be entitled to acquire and transfer Class B shares in Tele2 to the participants in LTI 2024.

Authorisation for the Board to resolve to repurchase own shares (item 20)

The Board proposes that the Board is authorised to resolve on repurchasing the company's own shares if the purpose is to retire shares through a decrease of the share capital, as well as to ensure delivery of B-shares to the participants in the Tele2's long-term incentive programmes, in accordance with the following conditions:

- The repurchase of Class A and/or Class B shares shall take place on Nasdaq Stockholm in accordance with Nasdaq Stockholm's rules regarding purchase of own shares.
- The repurchase of Class A and/or Class B shares may take place on one or more occasions for the period up until the next Annual General Meeting.
- So many Class A and/or Class B shares may, at the most, be repurchased so that the company's holding does not at any time exceed 10 percent of the total number of shares in the company.
- The repurchase of Class A and/or Class B shares at Nasdaq Stockholm may occur at a price within the share price interval registered at that time, where share price interval means the difference between the highest buying price and lowest selling price.
- It is the from time to time lowest-priced, available, shares that shall be repurchased by the company.
- Payment for the shares shall be made in cash.

The purpose of the authorisation is both to give the Board flexibility to continuously decide on changes to the capital structure during the upcoming year, and thereby contribute to increased shareholder value, as well as to hedge delivery of B-shares to the participants in Tele2's long-term incentive programmes, in accordance with the resolution under item 19(d) and previous Annual General Meetings' resolutions.

Resolutions proposed by shareholders

Proposal from the shareholder Sune Gunnarsson (item 11)

The shareholder Sune Gunnarsson proposes that if the Annual General Meeting resolves on a dividend, the dividend resolved upon by the Annual General Meeting shall be paid on one occasion, with the record date of 17 May 2024.

Proposals from shareholder Martin Green (items 21 (a)-(c))

Shareholder Martin Green proposes that the Annual General Meeting resolves:

- (a) that an investigation is carried out regarding the company's procedures to ensure that the current members of the Board and Leadership Team fulfil the relevant legislative and regulatory requirements, as well as the demands that the public opinions ethical values places on persons in leading positions. In addition, the investigation shall include the current attitude and practical handling performed by the company's administrators and executives,
- (b) in the event that the investigation clarifies that there is need, swift, relevant measures shall be taken to ensure that the requirements are fulfilled, and
- (c) taking into consideration the nature and scope of any needs, the investigation and any measures should be presented as soon as possible, however not later than during the Annual General Meeting 2025.

Miscellaneous

Shares and votes

As at the date of this notice, there are a total number of 696,221,597 shares in Tele2, whereof 22,446,882 Class A shares, 670,674,715 Class B shares and 3,100,000 Class C shares, corresponding to a total of 898,243,535 votes. As at the date on which this notice is disclosed Tele2 holds 1,488,520 of its own Class B shares and 3,100,000 of its own Class C shares, corresponding to a total of 4,588,520 votes which cannot be represented at the Annual General Meeting.

Special majority requirements with respect to the proposed resolutions in items 19 and 20

Resolutions under items 19(b), 19(c), 19(e) and 20 are valid only if supported by shareholders holding not less than two-thirds of both the votes cast and the shares represented at the Annual General Meeting.

Resolution under item 19(d) is valid only if supported by shareholders holding not less than nine-tenth of both the votes cast and the shares represented at the Annual General Meeting.

Authorisation

The Board, or the person that the Board appoints, shall be authorised to make the minor adjustments in the Annual General Meeting's resolutions as may be required in connection with registration at the Swedish Companies Registration Office and Euroclear Sweden.
